Extra-Curricular Items and Activities

Financial Support for Families

Tyabb Primary School understands that some families may experience financial difficulty and offers a range of support options, including:

- Centrepay by instalments through your Centrelink payments.

Payment methods

Our preferred payment method is through the Sentral app or payment can be made by:

Cash, cheque, credit/debit card, direct deposit to schools account BSB 063-093 Account 10000917, BPAY and Centrepay.

Refunds

Our school will consider requests for partial or full refunds of payments made by parents on a case-by-case basis taking into account the individual circumstances.

Generally we will not be able to refund payments made for items purchased or costs that have already been paid where those funds have already been transferred to a third party. For example, camp costs when a child becomes unwell and cannot attend in circumstances where the payment has already been made or committed to a third party and no refund is available to the school. Where possible, we will make this clear to parents at the time of payment.

Refunds of less than \$50 will be processed as a credit note onto the family account. For refunds greater than \$50 the parent may choose to have the amount as a credit note on their account or be paid by direct deposit to their bank account.

Refunds are never to be paid by cash to the parent or the student or through the EFTPOS facility.

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.
